By donating and submitting an entry form, you agree to the Campaign Rules.

1. Sponsoring Organization

2. Campaign Overview

In celebration of DMICF's 1st anniversary, the DMI Children's Foundation is hosting a Birthday Giveaway campaign. Participants who make a qualifying donation and complete the entry form will be entered into a drawing for a chance to win one of three prizes of their choice.

3. Campaign Period

- Campaign opens: Monday, June 1, 2026
- Entry deadline: June 30, 2026 at 11:59 PM EST
- Drawing date: July 2nd, 2026, time TBD.
- Winner notification: By email on or shortly after July 3rd, 2026

4. How to Enter

Entry requires TWO steps. Both must be completed to be eligible for the drawing:

Step 1 — Make a Qualifying Donation

Make a minimum donation of \$25.00 USD via the official DMICF GiveCloud donation page at dmicf.com/donate. Donations may be made as a one-time gift or as a recurring monthly gift. Only one entry is issued per donor regardless of donation amount.

Step 2 — Complete the Entry Form

After completing your donation, submit the official entry form via the provided Google Form link. You will be asked to provide:

- Your full name and email address
- Your GiveCloud donation confirmation number
- Your prize preference (in the event you win)

5. No Purchase Necessary

6. Donor Recognition

7. Prize Descriptions

One (1) winner will be selected and will choose ONE of the following three prizes:

Prize Option A — Memo Orthopedic Shoes

- Winner receives one (1) pair of Memo orthopedic shoes of their choice
- Winner may select any style or size available through Memo's current collection
- Approximate retail value: varies by style selected (approximately \$120USD)
- DMICF will send Memo Shoes the winner's preferences, sizing, and shipping information on the winner's behalf.

Prize Option B — \$1,000 Therapy Intensive Funding

- Winner receives up to \$1,000.00 USD in funding toward a DMI therapy intensive
- Funds are paid DIRECTLY to the treating clinic or therapy provider — no cash or payment will be issued to the winner personally
- Winner is responsible for scheduling and arranging their own therapy intensive with a DMI certified provider
- Winner must submit the therapy invoice to donations@dmicf.com after completion of the intensive
- DMICF will pay the agreed award amount of up to \$1,000.00 USD directly to the provider upon receipt of invoice
- We kindly ask the winner to provide photos, videos, testimonials of their experience to be shared publicly
- Winner is financially responsible for any remaining balance exceeding \$1,000.00 USD
- If the total cost of the intensive is less than \$1,000.00 USD, the remaining balance may be applied toward a future DMI therapy intensive
- Scholarship funds may only be used for therapy services and may NOT be applied toward travel, transportation, lodging, meals, or any non-therapy related expenses
- Winner will receive a scholarship contract that outlines all of the above
- Value: \$1,000.00 USD

Prize Option C — \$800 Therapist Certification Scholarship

- Winner must be a licensed therapist wishing to become DMI certified or a family wishing to award the training course to their licensed therapist of choice.
- Scholarship funds may only be used for course tuition and may NOT cover travel, transportation, lodging or meals.
- Funds are paid DIRECTLY to the DMI training or certification program. No cash or payment will be issued to the winner personally
- This option is particularly meaningful for families who wish to expand access to DMI-certified therapists in their community
- Approximate retail value: \$800.00 USD

Prize funds under Options B and C are never disbursed directly to the winner. All payments are made by DMICF directly to the relevant clinic/provider.

- DMICF will make reasonable attempts to contact the winner within 3 business days of the drawing
- The winner must respond to the notification email within 7 calendar days of notification
- If the winner does not respond within 7 days, the prize will be forfeited and an alternate winner may be selected at DMICF's discretion
- The winner must confirm their prize selection in their response email
- Full prize terms and any required documentation will be provided to the winner upon confirmation

10. Prize Conditions & Limitations

- Prizes are non-transferable and have no cash redemption value
- DMICF reserves the right to substitute a prize of equal or greater value if a selected prize becomes unavailable
- Prize acceptance constitutes winner's consent to DMICF's use of their first name and general location for promotional purposes
- All federal, state, and local taxes on prizes are the sole responsibility of the winner
